- 7. COMMUNICATIONS, PETITIONS, AND CLAIMS- Clerk of Council Sekerak explained that she had a request from Mr. Patrick Orwig to read into the record the following communication, was sent Sunday, December 11, 2022. To Council my name is Patrick Orwig and my wife Jennifer, and I reside at 5733 Skyline Drive tonight will be the first meeting since mid to late last year that I have not attended a scheduled Council meeting due to a death in the family. My attendance has always been to learn and participate after I was surprised to learn about a volleyball court near my property as you have shown in presentations from the administration. I continue to seek the Council's attention regarding the inappropriate placement of the volleyball court at North Park, but Council says it is an administrative matter. The administration has stated that the placement will remain because there are higher priorities for the parks, and both the Mayor and I agree the Council is within its rights to direct the mayor to take other action.

Mr. Orwig explained that the court is too close to the residences, the statement is further relegated by a taller fence being proposed. He further explained that no consideration is given related to noise at 4,000 square feet from our property line. The court is over twice as large as well as less than half the distance to residences as was the original its placement is a pure hindrance to the enjoyment, appearance, and value of our homes. Mr. Orwig asked the Parks and Recreation Committee, or the Chairman meet with me regarding my alternative plan to review the matter with the parks director asking that they provide an alternative solution for the volleyball court replacement at North Park respectfully Patrick Orwig - 5733 Skyline Drive.
