COUNCIL OPEN TO THE AUDIENCE

Patrick Orwig, 5733 Skyline Drive:

Mr. Orwig asked Council President Kiriazis if he received the email that he sent to him regarding the Volleyball Courts at North Park. Council President Kiriazis replied that he received it. He also said that he sent an email to the members of Council concerning the placement of the volleyball courts at North Park.

Mr. Orwig said that the volleyball courts are 23 feet away from his property line. He outlined the basics and his research that the placement violates common park installation of the courts.

He added that the bottom line is that he is not getting anywhere with any City Officials and the City spent hundreds of thousands of dollars to have the parks evaluated. From what I understand, the volleyball courts were one of the things for a professional park designer to do.

I am asking that someone from Council make a motion to ask the Mayor to contract with the company we are working with and ask them to evaluate where a volleyball court should be placed at North Park. That is what I am asking.

Mr. Orwig stated that he has done a lot of research. I am going to wait here and if anyone is interested, I am looking for an ally. At this time, I do not feel like I have an ally on this issue. Thank you and I appreciate your time.

Mr. Elliott asked if he said the location of the park or the location of the volleyball court? Mr. Elliott stated that it is the volleyball courts. Mr. Elliott asked if his biggest concern is the location of the courts? Mr. Orwig stated it is and the volleyball courts will be placed 20 feet from his fence.

The basketball and other courts are 150 feet away from residents' homes. I do not have a problem with that at all. But 20 feet is 10 times closer than any active sport at North Park. The people are using it and I know what it is like to sit on my patio to listen to people playing, and cussing right there. Come over and see what it looks like when you are sitting on his patio.

Mr. Elliott asked Ms. Burger if this is a legit issue he has? Ms. Burger stated that she has not measured it out. I know the Service Department worked hard on preparing the drainage on it and moving it.

Ms. Burger said this is the first and most thorough that I have heard about Mr. Orwig's concerns. She stated that she will measure it out and get back to Council.

Mr. Elliott told Mr. Orwig that he will stop tomorrow. He would like to look at it and the City might be liable to put a fence up to keep the balls from going into people's yards. It seems that it could be a big issue. Ms. Burger said that she is working on it.

Mr. Orwig said that the fencing is there and the balls are coming into the yards, not every time. Mr. Elliott said you have people running in other peoples' yards and dogs around?

Mr. Orwick had recordings from his phone of the conversation that he can hear. Mr. Elliott said that you bought a house next to a park and there were not too many kids up there. I don't know if you were living there at the time, but we had a football league and you moved next to a park and you had to understand that people will have fun, laughing, etc.

Mr. Orwig stated that he accepts full responsibility for buying a home near a park. My wife and I are fans of the parks. I assumed that I had a reasonable complaint to the City of Seven Hills.

Considering the size of this area I could never imagine that my neighbor would have elected to put up a volleyball court that is 20 feet from his property. This was stated by me in June and July, 2021 before Phase One of the construction was even finished.

I bet this wouldn't be in compliance with the Metro Parks. (Inaudible)

Mr. Orwig asked for one final point. The meeting in the Council Chambers took place because he literally walked in the volleyball pit and stood in front of the bulldozer. The workers called the Mayor's Office and that is how that happened.

Mr. DiChiro asked Mr. Orwig if he received copies of your request and the big book? Mr. DiChiro will have someone contact you tomorrow and see if they are available.

Council President Kiriazis thanked Mr. Orwig and asked Ms. Burger to look into this matter.

Ms. Burger replied that she would.
