I am proud to announce that Cuyahoga County Council approved our application for a \$250,000.00. Grant. That will be used for a portion of the North Park Pavilion. This amount will cover one-fourth of the cost of the pavilion. Our projection for this project is about a million dollars.

We have asked Cuyahoga County for \$250,000.00 for the splash pad and for funding from the Arbor Funds. This will be the last one that we have an opportunity to be awarded and not confident on receiving same, since we already received \$250,000.00. We have applied for a \$150,000.00 supplemental grant that comes from the lottery money that we would use to build the Observation Tower at Calvin Park.

Thanks to Jen Burger for her hard work in applying for the grant in the amount of \$250,000.00 from Cuyahoga County for the pavilion. Ms. Burger was required to make a presentation before the County Officials.

Mayor Biasiotta extended Congratulations to Councilman Dell'Aquila who is now an Ohio State Representative. He is in Columbus and I know that he will fight hard for tax dollars for Seven Hills.
