REPORTS AND COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

The Mayor discussed the 2023 Road Program, and he thanked Council for passing Ordinance No. 25-2023. He said that the 2023 Road Program is a very robust one. The community supports road improvements. Since 2016, we have spent over 15 million dollars on our City streets. Those in the City for the last four years can really see the difference. We also do partnerships with our surrounding communities.

The Mayor said the passage of Ordinance No. 20-2023 is huge. The Mayor said that he discussed this program with Chief Meklemburg when he first joined our community. The Mayor said that he is familiar with the Allison Rose fund raising events.

Many of our personnel have been trained in the use of the EpiPen. It is a requirement and we had to have qualified people. This is such a benefit. The pens will be provided by the Allison Rose Foundation, and we have found a partner to cover the cost. The pens will be distributed for our events throughout our City. He gave the statistics on the lives lost for lack of the availability of an EpiPen. Many people do not know they have an allergy to something. He thanked the Allison Rose Foundation for the funding and to Chief Meklemburg for his work on the project. Also, thanks to the Village of Cuyahoga Heights for their initial help with this project.

Mayor Biasiotta stated that the new playground equipment and fitness equipment will be arriving at North Park soon. Also, The City received a grant for the fitness equipment.

Director of Public Service & Properties Johnson – discussed the sand volleyball courts. He said that most people do not know what goes into building a volleyball court. The first factor is the drainage. Our costs for drainage, equipment and employees' time and the cost of moving same, would be approximately between \$25,000. to \$30,000. And, then the same amount to replace and duplicate the volleyball courts.

City Engineer Schmitzer – no report.

Building Commissioner Grassi – gave an update on permits and there were 33 permits issued and 39 contactors' registrations this month compared with the 31 contractors registrations that were processed in 2022. The insurance claim that the city filed on the contractors bond for the site restoration of Rockside Road and Skyline Drive has been settled now the site restoration can be completed weather permitted. The Planning Commission meeting on April 5th has been canceled due to a lack of submissions, and The Zoning Board of Appeals will meet on April 12 and there are two requests on the Agenda.

Councilman Kiriazis asked Councilwoman at-Large Kelly if she wanted to talk about this. Councilwoman Kelly thanked Council President Kiriazis and said she had a brief synopsis as Mr. Sapp mentioned at the podium earlier on March 15th the ZBA heard a variance request from Mr. Sapp at 2552 Chestnut Road, but just to be clear the variance report is not for an additional structure on his property. She explained it is to keep his current structure that has been in place since 2003 which is a storage structure built on a concrete slab with galvanized pipe and heavy duty tarps the resident came before the board because a new neighbor moved in and complained about the subject's structure. Mr Sapp collects and restores antique John Deere tractors that he uses for parades and educational uses. He has seven tractors in his collection, and they range from 70 to 90 years old. Z.B.A. Chairperson Bruins visited the residence and he noted that it is very well kept, and nothing is out of order it was also noted by the residents that were in attendance on behalf of Mr. Sapp that he has been a stellar neighbor who often helps his neighbors with yard maintenance and whatever else they need to assist in their yard. On March 15th three out of five member of the Z.B.A. were present, and all three voted in support of the variance request there were two residents present who supported Mr. Sapp one of which was curious as to why he was notified of the variance since he did not object to the variance. Councilwoman Kelly explained there was one objection to the variance that was sent in the form of a letter.

Council President Kiriazis further explained the motion was three to nothing for the variance and asked for a motion.
