This is for the Rockside Road project and it puts the City in a better light and he is happy with how it turned out.

This parcel is a piece of commercial property, with good size frontage. It is adjacent to the last three-acre parcel that we already purchased. We now control over 3 ½ acres on Rockside Road and this is a prime area and this gives us a variety of uses for this property. We will control it and we can develop it or not develop. Eventually, a portion will become a right turn lane.

Mayor Biasiiotta thanked all those who were involved in the purchase. He thanked Councilman Elliott and Assistant Law Director DiChiro for all of their assistance.

Mr. Dell'Aquila said the purchase of this property puts the City in a much better position.

Mr. Strnisa question was in reference to Councilman's Martin's article in the recent City Newsletter. He stated that the article referenced how certain City positions were appointed and/or elected. In particular, the Law Director's position.

Mr. Strnisa inquired if there is a current Law Director in place or will it be on the ballot in November?

Mayor Biaisiotta said that he will respond to this question in miscellaneous comments.

Also, Mr. Strnisa had a flooded basement on August 7, 2022 at his home. The City was notified and the Service Department came and took care of the problem. He notified his Councilperson, and he did respond. The Councilman said he has no authority regarding a resolution to his problem. Mr. Strnisa said they talked to a legal representative regarding the financial losses due to the basement flooding.

The Service Department stated that the blockage was in the main sewer line at the street and not on his property. Mr. Strnisa stated that this is a financial loss out of his pocket and the City should be responsible. He asked who he should talk to about his case and come to a resolution?

Ms. Kelly asked if he had engaged the services of an attorney. Mr. Strnisa said the attorney is a family friend and he is not on a retainer. A letter was sent by his friend/attorney and to Councilman Martin.

## REPORTS AND COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

The Mayor addressed Mr. Strnisa and said he would have our Law Director make an appointment to meet with him. The Mayor discussed what filing a moral claim consists of doing. Mr. DiChiro will contact Mr. Strnisa.

The Mayor discussed the Public Records requests and he has instructed his staff to reach out and fill the recent public records request by Mr. Orwig. The Mayor discussed Mr. Orwig's concerns and had the report from Brandstetters and discussed the concept.
