Russ Mazzola, 1032 Cherry Lane, made the following comments:

“I just want to take this chance to thank Matt and Jim for putting on that clinic about the project for the septic tanks. Unfortunately, I was a little sticker shocked – this is about 50% more than the phase part. All I want to ask you, because if I got this right, part of the cost is going to be replacing streets. And I would like if maybe Council could look into that – I’m not sure why that’s going to happen. I live on Cherry Lane and we just got a new street just a few years ago. So if that’s really the case – and I’m glad you did this ahead of time – because it would have been a little bit more of a surprise, I think, than it happened last time. So I appreciate that. I just think maybe this gives us some time to figure out how we can cut that cost for these residents, because \$20,000.00 as opposed to \$14,000.00 last time is a pretty big jump. That’s all. Thank you.”

Council President Trafis thanked Mr. Mazzola for his comments.

Bill Mason, 3667 Rachel Court, made the following comments:

“Good evening. I’d like to address a couple of issues if you don’t mind. It was our group that made that offer for the two parcels, acre and one-half, that the City of Seven Hills currently owns. A couple of things that you’ll find – and most of it, some of the things we talked about – are wetlands mitigation, some of the things we’d like to talk about further. But most importantly part of what we’d like to see, if you accept that offer, is that you make the Planned Unit Development cover that area – the city-owned property.”

Mr. Mason continued:

“Secondly, we put together a little bit of a proposal for the installment of the road right there on Rockside Road which the City owns. What we propose to do is put the mouth of the road in, all the way through the Seven Hills property, and abut immediately next to LSB Seven Hills land so they can tie in to the road. And then leave it open for us to tie in with our road coming down the First Energy property. Matt, I’ve submitted you a copy of that. I think if you circulate that to the members, maybe they can appreciate that a little bit better.”

Council President Trafis replied, “I’d be happy to.”

Mr. Mason continued:

“Next I’d like to talk about the easement that has to do with the City of Independence. Now at the southern-most part of the property, when we purchased this property from First Energy, we purchased an easement with it – a sixty-foot wide easement going from east to west, from Seven Hills across Independence on Oak Tree Boulevard. That’s part of the purchase price that we’re closing on in about three weeks. I’m going to leave for you a copy of the easement so all of you can see what it means.”

(A copy of ‘Declaration of Easement’, Cuyahoga County Recorder No. 200010260004, dated October 26, 2000, consisting of twelve (12) pages, is attached to the original copy of these minutes as an exhibit.)

Mr. Mason continued:

“There’s a lot of background noise about it, but this is the easement that was recorded that is part of the land of record, and we will work that out with the land owner over there in Independence. Now, unfortunately, last Thursday when we had this meeting, somebody who was in the audience thought it was their business – or not – but went and approached or talked to the land owner of that property and gave them a lot of half-truths, or whatever that might be, and I’m just going to suggest to you that this is an issue that won’t be an issue. We’ll have that worked out.”

Bill Mason (continued):

“Also, last Thursday we talked about – to the developers, myself.....I took that to be myself.....and the other group – we talked about tax increment financing and what that meant. And Council President Trafis asked us each to submit a letter if we intended to use tax increment financing as part of our project. I submitted to Matt earlier today indicating that on the land that we are purchasing from First Energy we are not going to be asking the School District or the City to pay for those roads. I’m talking about that road that will go all the way up, and I’ll attach a copy and you will all see what I’m talking about, but we’re not going to be asking you for government assistance on that. We will pay for our own road and we will develop it that way.”

Mr. Mason continued:

“The only portion we will ask for the City to help with is on the mouth of the road, off Rockside Road, that breaks off into the LSB Seven Hills property. That’s going to cost, we think, about \$350,000.00 to \$400,000.00 – we’d like to do tax increment financing for that cost. First in would pay that back, and that’s all we’d be asking from it. So that would benefit us, it would benefit LSB, and it would benefit the entire City for that to happen.”

Mr. Mason concluded:

“So, most importantly, my last thought is that I think Lloyd Chapman, who spoke earlier in the Caucus Room, spoke about the value of that parcel – your property, the one and one-half acres. I think what he said is most telling. That land is worth its most value you will get from it if you include it in the PUD. If you don’t include it in the PUD then any buyer is going to have some uncertainty about what their possibilities are and what they can accomplish down the road. You may say you might want to do it, but until it’s done, it’s not worth what it is as a part of the Planned Unit Development. And I’d ask you to consider that when you go back and deliberate to make it part of that. Thank you.”

Council President Trafis thanked Mr. Mason for his comments.

Council President Trafis added, “I will ask the Council Clerk to distribute the letters that you provided to me today, Bill.”

Director of Public Service and Properties Lovece:

To answer Mr. Mazzola's question regarding the Hemlock Creek Sanitary Sewer Project. Part of the reason why it's very expensive is, one, it's the most difficult sanitary sewer project the City has undertaken. The topography makes it very difficult. There are other factors, but all the easy stuff has been completed over the years. Now we have the more difficult project which involves over 300 families. This project does include road repairs and repairs to storm sewers. To not do it wouldn't be the right thing. The roads – most of the streets – the roads are currently falling apart to begin with. With construction traffic, it will further deteriorate. So, the roads will be repaired as part of that project. And storm sewers, as well – water mains – everything we can find underground that needs repair, we're going to fix it and do it right rather than come back and have another project.

The way we save money – the Service Department did a lot of the televising of the storm sewers and that provided valuable input on what has to be repaired. I'm just giving you an explanation. I know it's a difficult project. We are receiving \$1.1 million in grants for the water main replacement, and \$2.4 million for the overall project from the Ohio Public Works Commission. So there is some money to offset it, but it is a difficult project.

Council President Trafis further addressed Mr. Mazzola who was seated in the audience:

“Russ, if you want to ask questions about it, give Stewart a call. If you don't have his number, I'm sure he has a card he can give you after the meeting. Thanks, Stewart.”

Building Commissioner Moro was not present.
